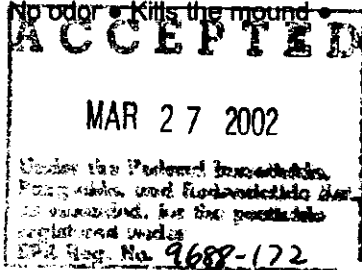

## MOUND TREATMENT

[Kills the queen and colony]

1. (graphic) Sprinkle 1/2 cup granules over and 2 feet around each mound.
2. (graphic) Immediately after applying, *GENTLY* water in granules using at least 1 gallon of water for each mound.
3. Treat new mounds as they appear.
4. For spot treatment of ants, other than fire ants: Apply 1 – 1 1/2 teaspoons over and around each ant hill.

## [OPTIONAL DIRECTIONS FOR BROADCAST TREATMENT]

[Kills foraging ants]

*The use of broadcast treatment is not intended to be a substitute for fire ant mound treatment. For effective fire ant control you must also treat the mound.*

1. Apply granules with a spreader at a rate 2 lbs. per 1,000 sq. ft.
2. Water lawn immediately after application.
3. Do not mow for 24 hours following treatment.

## USE TIPS

1. (graphic) For best results, apply in morning or evening hours. At these times, fire ants are closer to the surface virtually assuring the product will contact them.
2. Gentle application of water is important as high pressure spray may disturb ants and cause migration, reducing product effectiveness.
3. Food utensils such as spoons or measuring cups must not be used for food purposes after use in measuring pesticides.

**STORAGE AND DISPOSAL**

Reclose bag tightly after each use. Store in a cool, dry area which is inaccessible to children and pets. **If empty:** Do not reuse this container.
