The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the lambda-Cyhalothrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.



Keep children and pets off treated areas until product has been watered in and treatment area is dry.

All applications must be limited to applications directly to fire ant mounds and ant hills.

Do not apply within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios.

Do not apply or irrigate to the point of runoff. Treat surfaces to ensure thorough coverage but avoid runoff.

Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where

drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

MOUND TREATMENT

[Kills the queen and colony]

- 1. Sprinkle 1/2 cup granules over and 2 feet around each mound.
- 2. Immediately after applying, *GENTLY* water in granules using at least 1 gallon of water for each mound. Do not apply within 24 hours of rain. Do not allow to run off from target site.
- 3. Treat new mounds as they appear.
- 4. For spot treatment of ants, other than fire ants: Apply 1 1 1/2 teaspoons over and around each ant hill. Spot treatments must not exceed two square feet in size (for example, 2 ft. by 1 ft. or 4 ft. by 0.5 ft.).

USE TIPS

- 1. For best results, apply in morning or evening hours. At these times, fire ants are closer to the surface virtually assuring the product will contact them.
- 2. Gentle application of water is important as high pressure spray may disturb ants and cause migration, reducing product effectiveness.

STORAGE AND DISPOSAL

Reclose bag tightly after each use. Store in a cool, dry area which is inaccessible to children and pets. **If Empty**: Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. **If Partly Filled**: Call your local solid waste agency for disposal instructions. Do not pour or dispose down-the-drain or sewer. Call your local solid waste agency for local disposal options.
