The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Lambda-Cyhalothrin and Gamma-Cyhalothrin Interim Decision and the Prallethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. 

## For Ground Nesting Yellowjackets

Using [attached][included] extension tube spray product directly into holes in ground where yellowjacket activity has been observed. After 24 hours cover the hole with soil. For best results spray early in the morning or late in the evening when was activity is low and most yellowjackets are in the nest.
