EPA acknowledges receipt of revised methodology (submitted October 9; MRID # as yet unassigned) to fulfill this requirement. EPA will review the revised method to determine whether it is acceptable and will advise you of our determination once the review is completed.
3. Submit product chemistry data to satisfy guidelines 830.6320 (corrosion characteristics) and 830.6317 (storage stability). I understand that these data are currently under development. Please submit the results of these studies when they are completed.

4. Submit a corrected CSF, revising the amount of the carrier in the product, so that the total weight of all components is equal to 100.000 lbs.. The amount in column 13a should be 78.430 lbs., not 78.529 lbs. The percent by weight in column 13b should also be 78.430. Adjust the certified limits to reflect this slight correction.
  
5. Submit two (2) copies of your final printed label before you release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling.
