Name of Pesticide Product: Chemsico Herbicide Concentrate DP

This product is conditionally registered in accordance with Section 3(c)(7) of the Federal Insecticide, fungicide, and Rodenticide Act, as amended, provided you submit acceptable one year storage stability and corrosion characteristics studies within 18 months of the date of this registration.

Make the following label changes listed below before you release the product for shipment:

1. Add a statement of the weight of active ingredients per gallon of product.
2. Follow the directions in Chapter 3 of the EPA Label Review Manual for proper sizing of the "Signal Word" and "Keep out of Reach of Children." (Refer to EPA's web site: <http://www.epa.gov/oppfod01/labeling/lrm/index.html> for information).
3. Under "Precautionary Statements":

Replace the sentence "Harmful if absorbed through the skin." with "Harmful if inhaled or absorbed through the skin."

4. Under "How to Apply";

Add the following statements:

"Do not apply this product in a way that will contact any person or pet, either directly or through drift. Only persons apply this product may be in the area during application."

5. Under "Storage and Disposal";

Change "Storage" to "Pesticide Storage" and "Disposal" to "Pesticide Disposal."

6. Under "Notice":

The Agency has not reviewed or accepted the liability statement. It may need to be changed at a later date.

7. Make the following label changes listed below before you release the product for shipment:

Add on the front panel, "EPA Reg. No. 9668-218" and "EPA Est. No. 9668-XX-XX."

8. You are required to conduct one year storage stability (EPA 830.6317) and corrosion characteristics (EPA 830.6320) studies. Submit the test results for review and acceptance on completion.

Submit one copy of your final printed labeling before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

How it Works: Chemsico Herbicide RTU DP is an easy to use product that kills and prevents the regrowth of unwanted grass and weeds. One application kills the plant down to the root and prevents regrowth for up to 1 year [12 months]. Chemsico Herbicide RTU DP keeps your driveways, patios, sidewalks looking beautiful with one easy application.

Where to Use: In driveways, sidewalks, paths, patios, parking areas, play areas, along fences and curbs, around buildings and graveled pathways where plant growth has come through the surfaces.

When to Use: For best results, apply to bare ground when [weed] [vegetation] growth is just starting. Weeds taller than 4-6 inches should be mowed or hoed before treatment.

[GENERAL INFORMATION] [HOW TO USE] [THINGS TO KNOW]

Chemsico Herbicide RTU DP is a nonselective product which will kill almost all vegetation down to the roots and prevent plant regrowth. When applied to the soil this product can inhibit plant growth for up to one year. Residual control increases as rates are increased.

[USE SITES]

- Use around the home where no plant growth is desired.
- [Chemsico Herbicide RTU DP is intended] for bare ground vegetation control in driveways, sidewalks, brick walks, paths, patios, parking areas, play areas, along fences and curbs, around buildings, and graveled pathways where plant growth has come through these surfaces.

Do not use on lawns, flowerbeds, or vegetable gardens. Chemsico Herbicide RTU DP should not be applied over the root zones of desirable trees or shrubs. Do not apply in sloped areas where runoff may adversely affect desirable plants.

For Best Results: Although Chemsico Herbicide RTU DP has considerable activity through foliar contact, much of its activity is through roots; therefore, **its effectiveness is dependent on rainfall to move it into the root zone. Very dry soil conditions and lack of sufficient rainfall may result in poor weed control.** For best results, if the soil is dry, water lightly before treatment. Apply Chemsico Herbicide RTU DP directly to weeds and grass. Thoroughly wet weeds but do not soak as runoff may occur. Two days following application, lightly water the treated area. This will aid in the killing and prevention of weeds through root absorption.

WHEN TO APPLY

- For best results, apply to bare ground or when weed growth is just starting.
- Weeds taller than 4 inches should be hoed or cut to 1 inch in height before treatment or it may be necessary to make a second application.
- A second application may also be necessary to control deep-rooted perennial weeds. In areas of heavy rainfall, repeat application may be required every six months.
- Application on sunny days with the temperature above 60° F will result in faster control of existing weeds.

[EzSpray Directions]

1. [Unwrap sprayer.] Remove sprayer from side holder. Gently pull tubing out. (Graphical representation.)
2. Remove seal from top of cap. Unplug cap. (Graphical representation.)
3. Securely snap the [yellow] plug into hole on cap. (Graphical representation.)
4. Remove plastic tab near bottom of sprayer to activate batteries. (Graphical representation.)
5. Twist nozzle to adjust spray from CLOSE to SPRAY to STREAM. (Graphical representation.)

HOW TO USE THE EzSpray

1. Aim toward target weeds/plants, and away from people and pets.
2. Press the trigger to spray.
3. Release the trigger to stop spray.

After use: 1. Twist nozzle completely to CLOSE position. 2. Secure sprayer upright in holder. 3. **Failure to adjust nozzle completely to CLOSE position and properly secure sprayer in holder may result in leakage and damage to property or injury to people or animals.**

To replace batteries: 1. Slide battery compartment door to unlatch and open. 2. Remove used batteries and insert four new AA batteries in **correct positions** as marked per diagram inside of battery compartment. Never insert the positive end where the negative end belongs and vice versa. **Always** use a complete set of new batteries the same type when replacing batteries. **Never** mix alkaline, carbon-zinc or rechargeable batteries. 3. Securely close battery compartment door. 4. **Always** follow manufacturer's recommendations for use and disposal of batteries. **Additional Operating Notes:** Do not submerge in water. Before each use inspect sprayer carefully, make sure hose is flexible and not kinked, worn or cracked, and that all connections are tight. When storing sprayer for prolonged periods remove batteries.

SPRAY DRIFT MANAGEMENT:

Do not allow spray to drift from the application site and contact people, structures people occupy at any time and the associated property, parks and recreation areas, non-target crops, aquatic and wetland areas, woodlands, pastures, rangelands, or animals.

IMPORTANT USE PRECAUTIONS:

- To avoid damage to desirable plants, apply when it is not windy. Windy conditions may cause inadvertent drifting to desirable plants and grass.
- DO NOT apply over the root zones of desirable trees and shrubs.
- DO NOT apply to decorative rock or bark groundcovers where the soil is covered with plastic fabric or on slopes because runoff and/or leaching may result (apply only to level surfaces). In heavy clay soil locations, residual activity may exceed one year.
- DO NOT apply closer than twice the distance from the trunk of a tree to the drip line.
- Do not apply next to a fence if desirable plants are growing on the other side or if future plantings are planned.
- Vertically cut through any roots adjacent to root zone of desirable plants.
- Do not apply this product in a way that will contact any person or pet, either directly or through drift. Only persons applying this product may be in the area during application.

REFILL DIRECTIONS FOR EzSpray

Refill only with Chemsico Herbicide Concentrate DP. Remove cap. Carefully measure and mix 8 fl oz (16 Tbsp) in one gallon of water. Replace and tightly close cap. Wipe off any spilled product.

[HOW TO APPLY]**(Hand Sprayer Applicator)**

1. SHAKE WELL (graphic).
2. CONNECT TRIGGER SPRAYER. Unscrew and discard the [white] cap on the bottle. Insert the hose into the bottle and tighten the cap securely.
3. PRIME SPRAYER. Turn the sprayer nozzle one-half turn counter-clockwise. Hold the sprayer lower than the bottle and squeeze the trigger several times until it sprays. Adjust the nozzle to coarse spray pattern. Avoid sprays which are too fine because they can drift and damage other plants.
4. SPRAY UNWANTED GRASS & WEEDS UNTIL COMPLETELY COVERED. Wilting and browning will begin within hours.

(Trigger Sprayer Applicator)

1. SHAKE WELL (graphic).
2. Turn the nozzle to coarse spray pattern. Avoid sprays which are too fine because they can drift and damage other plants.
3. SPRAY UNWANTED GRASS & WEEDS UNTIL COMPLETELY COVERED. Wilting and browning will begin within hours.

Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.

[Hand Sprayer Applicator]

Turn the nozzle to "OFF" position and store with sprayer above the level of liquid in container to prevent leakage. **Storage:** Store in a cool, dry area away from heat or open flame. **Disposal:** **If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.

[Trigger Sprayer]

Storage: Store in a cool, dry area away from heat or open flame.
