It is a violation of Federal law to use this product in a manner inconsistent with its labeling.



Do not allow pets or people to enter treated area until fog is no longer present and spray deposits have dried.

For reduction in annoyance from flies, mosquitoes and gnats in yards, patios and around swimming pools.

Before application, remove animals from area to be treated. Cover or remove exposed foods during use.

Thermal applications – This formulation is to be used undiluted in only such portable thermal applicator equipment that can deliver spray particle sizes within the aerosol-size range.

Hold thermal applicator at least five feet from any object, especially plants and shrubbery. Avoid wetting any plant foliage. Fog only when there is no breeze, or the wind velocity is less than 3 miles per hour. The ideal time is generally at dusk when the wind dies down and the air temperature and ground temperature are approximately the same. Under these conditions the fog will linger in the treated area for a longer time. Apply fog while moving away from treated area. Avoid inhalation of the fog. Do not enter the treated area until the fog has dissipated. Repeat application when insects return. One quart treats 3,600 square feet.

STORAGE AND DISPOSAL

Storage: Store product in original container in a cool, dry, locked place out of reach of children and pets. **Disposal: If empty:** Do not reuse this container.
