 - (1) Three month bait station longevity How long will a the supply of bait in a station last if made available to a population of foraging cockroaches in a choice test? How long will 10 bait stations last if exposed to a cockroach population a kitchen area or equivalent?
 - (2) Lateral Transfer note that the submitted data showed that some lateral transfer occurs. However, a choice test is required to confirm the effect or impact of such transfer on cockroach population control. We recommend exposing live cockroaches to a tank of cockroaches killed by the bait that includes fecal material instead of transferring dead cockroaches to tanks of live ones as was previously done.
 - (3) An additional test that should be performed is a choice test in which cockroach feeding on untreated and treated bait matrices is compared.
