EPA Registration No. 9688-229 Chemsico Home Insect Killer L Your submission dated July 24, 2006

Dear Mr. Metzger:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided you revise the label according to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

The Agency reevaluated the data cited in support of the desired claims and concluded that only one of the four studies, MRID 4655804, is pertinent to the residual claim on "non-porous surfaces." The study supports a claim of "up to 5 months control on non-porous surfaces" for German cockroaches only, and a claim of "up to 7 months control on non-porous surfaces" for crickets (not a pest of public health concern). A copy of the Efficacy Review Memo is enclosed for your records.

- 1. Residual claims are acceptable only for "up to 5 months control on non-porous surfaces for German cockroaches" and "up to 7 months control on non-porous surfaces for crickets."
- 2. Kill claims, without any residual claims, are acceptable only for
  - o Ants (with the exception of Fire, Harvester, and Pharaoh's Ants)
  - o Cockroaches
  - o Fleas

- o Mosquitoes
- Spiders (with the exception of Black Widow and Brown Recluse spiders)
- o Crickets
- o Earwigs
- o Silverfish
- o Firebrats
- o Other pests, NOT of public health importance
- 3. The following claims are NOT acceptable
  - o "[kills] and keeps on killing"
  - o "protects"
  - o "continues to kill"
  - o "keeps killing [up to]"
  - o "kills up to..."
  - o "works up to"
  - o "controls"
  - o "control indoors on non-porous surfaces"
  - o "Lasts up to"
  - o "Up to...control"
  - o Any other residual claims

Please note that storage stability and corrosion characteristics data are still outstanding. You must generate and submit these data.
