The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the lambda-Cyhalothrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



Three Easy Steps to Use this Product

Step #1: Determine size of the job, measure the area to be treated.

Step #2: Use spreader setting chart to determine appropriate setting for your spreader.

Step #3: Treat as directed in rate chart. Thorough coverage is important. Water in granules immediately after application.

NOTE:

- Do not apply more than six (6) times per year per location at low use rate.
- Do not apply more than three (3) times per year per location at high use rate.

All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1. Application to pervious surfaces such as soil, and vegetation;

OPTIONAL DIRECTIONS FOR BAND TREATMENT

OPTION A

BAND TREATMENT AROUND HOUSE

General Directions

The following pests are commonly found around or near foundations of houses. Some of these pests may enter the home. Apply a 3 to 5 foot band of granules next to the house's foundation.

INSECTS:

Ants (except Carpenter and Pharaoh), Mites, Crickets, Earwigs, Fleas, roaches (German & American), Palmetto bugs, water bugs Millipedes, Sowbugs (Pillbugs)

RATE:

1.25 oz for each 100 sq ft area (5' by 20').

HOW TO USE:

Distribute granules evenly. Water lightly immediately after application.

SPOT TREATMENT FOR ANTS

(Except Carpenter and Pharaoh Ants)

RATE:

Apply 0.5 teaspoons over and around each anthill.

HOW TO USE:

Water lightly immediately after application.

OPTION B

BAND TREATMENT AROUND HOUSE

1. Chemsico Insect Granules LH kills ants (except Carpenter and Pharaoh), as well as fleas, mites, crickets, earwigs, millipedes, roaches (German & American), Palmetto bugs, water bugs, sowbugs (Pillbugs), silverfish, ticks (including ticks which may transmit Lyme Disease) and other listed pests.
2. Break the seal and open the pop-top cap.
3. Evenly sprinkle granules in a 3 to 5 foot wide band along the foundation of your home. Granules should be spaced like the ones pictured below (show picture). Use rate = 0.8 lb per 1000 sq ft (an area 5' x 200') or 1.25 oz for each 100 sq ft (an area 5' x 20').
4. Gently water treated areas.

USE TIPS

1. Try to get even coverage throughout your " band".
2. Reapply after hard rains to areas where down spouts empty.

SPOT TREATMENT FOR ANTS

(Except Carpenter and Pharaoh)

1. Evenly sprinkle granules over and around each anthill.
2. Apply (0.5 teaspoons) per anthill. [(NOTE: This package will effectively treat 64 anthills.) (The note is for a 2 lb package.)]
3. Gently water treated areas immediately after application.

STORAGE AND DISPOSAL

Storage: Reclose container tightly after each use. Store in a cool, dry area which is inaccessible to children and pets. **Disposal:** **If empty:** Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. **If partly filled:** Do not pour or dispose down-the-drain or sewer. Call your local solid waste agency for disposal instructions.
