Keep people and pets off treated areas until dry.

- 1. Shake well.
- 2. Adjust nozzle to coarse spray pattern to minimize wind drift. (graphic)
- 3. Spray just enough [Chemsico Herbicide WSG RTU] to lightly cover [broadleaf] ibrushyl weeds [brush]. Excessive spraying can injure some lawns. Do not spray weeds (brush) growing within the dripline of plants. (graphic) Do not apply when daytime temperatures are above 85°F as lawn injury can occur. (graphic) Use only as a spot treatment.
- 4. Weeds [brush] will begin wilting and browning overnight.

USE TIPS

- Some hard-to-kill weeds [brush] may require re-treatment. Wait at least 3 weeks between applications - some weeds [brush] can take that long to die.
- Rainproof [Rain fast] rain or watering 6 hours after application will still yield results. [If rainfall occurs within 6 hours of application, the product should be reapplied.]
- Do not allow spray to drift onto desirable plants since injury may result.

STORAGE AND DISPOSAL
