Dear Mr. Metzger:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

After comparing the basic confidential statement for formula of this product with the cited PBI/Gordon product, it was found that the two products are toxicologically substantially similar. Based on the toxicity profile of the cited product, the signal word for Chemsico Herbicide WSG RTU will remain as "CAUTION."

All other precautionary statements submitted with this label are therefore acceptable and any conflicting comments in the Agency's 2,4-D RED amendment letter dated January 27, 2009 and the final reregistration notice dated June 17, 2009 may be dismissed in light of this new toxicity profile.

Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.

Submit one (1) copy of final printed labeling before you release the product for shipment.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.



General Precautions and Restrictions

Do not apply this product in a way that will contact any person or pet, either directly or through drift. Keep people and pets out of the area during application. Do not allow people or pets to enter the treated area until sprays have dried.

- Shake well.
- 2. Adjust nozzle to coarse spray pattern to minimize wind drift. (graphic)
- 3. Spray just enough [Chemsico Herbicide WSG RTU] to lightly cover [broadleaf] [brushy] weeds [brush]. Excessive spraying can injure some lawns. Do not spray weeds [brush] growing within the dripline of trees. (graphic) Do not apply when daytime temperatures are above 85°F as lawn injury can occur. (graphic) Use only as a spot treatment.
- 4. Weeds [brush] will begin wilting and browning overnight.

USE TIPS

Some hard-to-kill weeds [brush] may require re-treatment. Wait at least 3 weeks between applications — some weeds [brush] can take that long to die.

- Rainproof [Rain fast] rain or watering 6 hours after application will still yield results. [If rainfall occurs within 6 hours of application, the product should be reapplied.]
- Do not allow spray to drift onto desirable plants since injury may result.

STORAGE AND DISPOSAL

Pesticide Storage: Store in original container in a cool, dry area away from heat or open flame and in an area inaccessible to children and pets. Keep from freezing. Container Disposal: If empty: Nonrefillable container. Do not reuse this container. Place in trash or offer for recycling if available.
