On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is **conditionally** registered in accordance with FIFRA sec. 3(c)(7)(A), provided that you:

- 1. You will submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. You will make the following label changes before you release the product for shipment:
- a. Revise the EPA Registration Number to read "EPA Registration Number 9688-249.".

- b. Change "Have the product container or label with you when calling a Poison Control Center or doctor or going for treatment." to "HOT LINE NUMBER: Have the product container or label with you when calling a Poison Control Center or doctor or going for treatment. You may also contact 1-800-xxx-xxxx for emergency medical information. Note to Physician: Contains petroleum distillates- vomiting may cause aspiration pneumonia.".
- c. The Agency is recommending that an "If Swallowed" statement be added to the First Aid section. The agency understands that, based on the method of application, it is unlikely that someone would swallow any of this product. We additional understand that this product is category IV for primary acute oral toxicity. However, based on the petroleum distillate concentration of this product, in the unlikely event that some of the product is swallowed, special precautions would be needed to be observed. A "Note to Physician" is required, based on the petroleum distillate concentration.
- d. Based on the acute toxicity profile you may delete the IF IN EYES and corresponding precautions, "causes moderate eye irritation".
- e. Residual control claims are not supported by these data. The data support the addition of the following pests with a "Kills" performance claim: Cockroaches, fleas, (adults only) black carpenter ants, spiders, moths, crickets, brown dog ticks, waterbugs, earwigs, palmetto bugs, pillbugs, black carpet beetles, rice weevils and saw tooth grain beetles.
  - f. Please submit or cite data for silverfish and/or firebrats.
- g. Please qualify the ant species to be kill or excluded from use or delete. Public health species require testing.
- h. Remove the claim "flying insects" because none were tested. No data was cited or submitted to support this claim.
- i. Add "or stored" to the end of the sentence, "... commercially prepared, processed or stored.".
- j. Delete the marketing claim, "Dead On... Every Time". Implied claims of heightened efficacy are not acceptable .

- 3. You must generate studies corresponding to guidelines 830.6317 (one year storage stability) and 830.6320 (corrosion characteristics). You are required to generate the one year storage stability study under warehouse conditions. The observations must be made at 0, 3, 6, 9, and 12 months intervals. The corrosive characteristic study may be carried at concurrently. The results must be submitted to the Agency along with and electronic format also.
- 4. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.


