The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the lambda-Cyhalothrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

HOW TO USE

1. Remove protective cap from tip of [tube][syringe][pouch]
2. Snip off end of tip [at notch] with a scissors.
3. Apply a thin [bead][line][strip] of gel to [joint][crack or crevice][areas][to be] treated.
4. Wipe tip with a [tissue][cloth][paper towel] to remove excess gel and throw in trash.
5. Replace protective cap on tip.

Apply in areas where **cockroaches, Palmetto bugs, ants**, clover mites, crickets, cigarette beetles, confused flour beetles, red flour beetles, rice weevils, saw-toothed grain beetles, dermestid beetles, firebrats, water bugs, silverfish, earwigs, box elder bugs, centipedes, and millipedes** are found or normally occur including dark corners of rooms and closets, cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations.

For ants**, apply to ant trails; around doors and windows and wherever else ants may find entrance.

OUTDOORS

DO NOT apply directly to residential lawns and turf in residential settings (e.g., homes, parks, schools, athletic fields or any other area frequented by the general public).

All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1. Application to pervious surfaces such as soil, and vegetation;
2. Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch, or groundcover that abuts the perimeter of treated structure);
3. Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure;
4. Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
5. Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.), up to 2 feet above ground level;
6. Applications to vertical surfaces directly above pervious surfaces, such as soil, mulch or vegetation only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

DO NOT apply directly to residential lawns and turf in residential settings (e.g., homes, parks, schools, athletic fields or any other area frequented by the general public).

Spot treatments must not exceed two square feet in size (for example, 2ft. by 1 ft or 4 ft. by 0.5 ft.).

Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

Do not apply or irrigate to the point of runoff.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

Do not make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

Treat surfaces to ensure thorough coverage but avoid runoff.

To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

Do not allow to enter indoor or outdoor drains. Follow proper disposal procedures on this label.

**[PERIMETER] [BARRIER] TREATMENT**

Apply a continuous band [of insecticide] around windows, doors, utility line entrances, eaves, vents and other areas to reduce the potential for entry by crawling pests. Remove debris and leaf litter from next to the foundation, cut back vegetation and branches that touch the foundation, and move or rake back rocks, deep mulch, or other potential pest harborage next to the foundation. **Kills ants**, Asian beetles, box elder bugs, centipedes, millipedes, flies, Asian beetles, and palmetto bugs**

NOTE: This product is non-staining to most exterior home surfaces depending on age and cleanliness. However, before using in areas where the gel may contact home siding (vinyl siding in particular), test in an inconspicuous area and recheck in a few hours. Do not use if any staining is observed.

WOOD DESTROYING INSECTS

Treat infested areas and areas likely to be infested, such as wood surfaces, voids and tunnels [channels] in damaged wood, behind veneers, in structural voids (between stud walls and spaces between wood and foundations, along cracks, along crawl spaces and around outside buildings, porches, wood piles, wooden fences and decks. Kills **exposed subterranean termites*, dampwood termites*, drywood termites*, carpenter ants, ambrosid beetles, death hunter beetles, false powderpost beetles and powderpost beetles.**
