On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is **conditionally** registered in accordance with FIFRA sec. 3(c)(7)(A), provided that you:

- 1. You will submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. You will make the following label changes before you release the product for shipment:
- a. Revise the EPA Registration Number to read "EPA Registration Number 9688-254.".
- b. The physical and chemical hazard statements on the label must be revised to read "Contents under pressure." Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperature above 130 degrees fahrenheit may cause bursting.".

- c. Add to the Hazards to Humans and Domestic Animals section "Contains petroleum Distillate."
- d. Even though the oral route of exposure is toxicity category IV please add the following statements: "IF Swallowed:- Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. These statements are required due to the petroleum distillate concentration of this product.
- e. Change "Have the product container or label with you when calling a Poison Control Center or doctor or going for treatment." to "NOTE TO PHYSICIAN: May cause an aspiration pneumonia hazard. Contains petroleum distillate.

Have the product container or label with you when calling a Poison Control Center or doctor or going for treatment. You may also contact 1-800-xxx-xxxx for emergency medical treatment information.".

- f. The data do not support inclusion of brown recluse spiders on the label. Therefore, remove spiders from the label.
- g. Change ticks to "Brown dog ticks" throughout the label. The data submitted does not support generic "tick" claims.
- h. The current tests provide information on carpenter ants and Pharaoh ants only. Therefore change the ants claim to read "Ants (except fire ants").
- i. German cockroaches 4 weeks of control is acceptable. A longer claim on non-porous surfaces is not supported because the mean value of control on ceramic and vinyl tile is less than 90% at 6 weeks.

A general cockroach claim of 6 weeks is acceptable based on the data for German and brown-banded cockroaches considered together. An 8 week claim is not acceptable. Therefore revise the residual claims on the label to read "Keeps on killing cockroaches for up to six weeks". Delete reference to 2 months or qualify it to pertain to house crickets on non porous surfaces.

- j. No residual control claims are acceptable for black carpenter ants.
- k. For house crickets: 8 weeks on non-porous surfaces and 4 weeks on all surfaces are acceptable.
 - 1. For brown-banded cockroaches: 8 weeks control is acceptable.
- m. On the front panel add "For Indoor Household/Residential Use Only". And delete the statement beginning "Do not use in commercial food handling establishments restaurants... etc.".

- n. Delete the claims 1) "Dead- on Every Time". Claims implying total eradication or elimination of pests are not acceptable., 2) "No unpleasant odor, No unpleasant residual odor, odorless". These claims are subjective depending on who you ask and also imply safety claims.

 3) Either delete "Treats 20% more area than 5000 cubic foot foggers" or qualify by adding the container size i.e. "... 20% more than 5 ounce 5000 cubic foot foggers.".
- o. The word "New" can be used on labeling produced for a period of six months from the date of this Registration Notice.

- 3. You must generate studies corresponding to guidelines 830.6317 (one year storage stability) and 830.6320 (corrosion characteristics). You are required to generate the one year storage stability study under warehouse conditions. The observations must be made at 0, 3, 6, 9, and 12 months intervals. The corrosive characteristic study may be carried at concurrently. The results must be submitted to the Agency along with and electronic format also.
- 4. Please note that a notice of availability of EPA's registration eligibility document (RED) for product containing Cypermethrin was published in the FR on August 16, 2006 (Vol 71 No 158 page 47210-47212). Additional data and/or labeling changes may be required for products containing Cypermethrin.
- 5. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
