The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Prallethrin and lambda-Cyhalothrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.



Do not allow children or pets into the treated area until dry.

All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

Application to pervious surfaces such as soil, and othervegetation.

Spot treatments must not exceed two square feet in size (for example, 2ft. by 1 ft or 4 ft. by 0.5 ft.).

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not spray the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

Do not allow the product to enter any drain during or after application.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

Do not apply or irrigate to the point of runoff.

Do not make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

Treat surfaces to ensure thorough coverage but avoid runoff.

To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

HOWTOUSE

- 1. SHAKEWELLBEFOREUSING.
- 2. Place extension tube in nozzle [and twist to lock into place]. [optional graphic]
- 3. Insert extension tube 3-4 inches into the side of the [fire ant] mound to be treated. Press nozzle and spray at 2-3 second burst of foam into the mound as you withdraw the extension tube. Repeat on opposite side of mound. [optional graphic]
- 4. Once two foam injections have been completed cover top of mound with foam. [optional graphic]

For best results apply in Morning or Evening hours. At these times, fire ants are closer to the surface virtually assuring that the product will contact them. [optional graphic]

STORAGE AND DISPOSAL

Storage: Store in a cool, dry area away from heat or open flame. **Disposal:** Do Not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Do not pour or dispose down-the-drain or sewer. Call your local solid waste agency for disposal instructions.
