#### NOTE TO PHYSICIAN or VETERINARIAN

Contains the nerve poison bromethalin. This product is not an anticoagulant type rodenticide. For humans or animals ingesting bait and/or showing poisoning signs (such as muscle tremors, loss of hind limb use, or seizures for animals), limit absorption by either emesis or gastric lavage. Sublethal symptoms, if present, would be the result of cerebral edema and should be treated accordingly through administration of an osmotic diuretic and corticosteroid.

### **ENVIRONMENTAL HAZARDS**

This product is extremely toxic to mammals and birds. Dogs and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait. Do not apply directly to water.

#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**READ THIS LABEL:** Read this entire label and follow all use directions and use precautions. Use this product only for the sites, pests, and application methods described on this label.

To help prevent accidents:

- 1. Store product not in use in a location out of reach of children and pets.
- 2. Dispose of product container and unused, spoiled and unconsumed bait as specified on this label.

USE RESTRICTIONS: DO NOT USE THIS PRODUCT OUTDOORS OR IN AREAS ACCESSIBLE TO PETS. This bait station may be used in indoor areas accessible to children, consistent with all use restrictions and other requirements indicated in this label.

Do not place this [ready-to-use] [refillable] [reusable] bait station in any area where there is a possibility of contaminating food or surfaces that come into direct contact with food.

**SELECTION OF TREATMENT AREAS:** Determine areas where house mice will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where house mice or their signs have been seen. Remove as much alternative food, water and harborage as possible prior to bait application.

**APPLICATION DIRECTIONS:** The active ingredient in this product is different from anticoagulant rodenticides. Individual house mice cease feeding after consuming a toxic dose.

**House Mice:** Place the bait station in areas where house mice or their signs have been seen. If additional units are to be used, place bait stations 8 to 12 feet apart. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replace with new bait at sites where there is heavy feeding or where there is continued evidence of house mouse activity. Continue baiting until all signs of house mouse activity have ceased.


While wearing waterproof gloves, collect and properly dispose of all dead house mice and used baits. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment.


### **DIRECTIONS FOR USE (CONTINUED)**

## INSTRUCTIONS FOR OPENING, FILLING , REFILLING AND RECLOSING THE MOUSE BAIT STATION):

1. To open the Bait Station, put on waterproof gloves and push down and turn cap counter-clockwise to remove.



2. If refilling, discard any remaining bait in the bait station. Place refill block on the pin in the center of the bait station opening.



- 3. Replace cap and turn clockwise to re-secure cap.
- 4. CLEAN AROUND THE BAIT STATION AREA BY REMOVING ALL REMAINING BAIT & BAIT CRUMBS. DISPOSE OF WATERPROOF GLOVES AND BAIT CRUMBS ACCORDING TO "PESTICIDE DISPOSAL BELOW." ENSURE THAT GLOVES & BAIT ARE DISPOSED OUT OF REACH OF CHILDREN, PETS AND WILDLIFE.
