The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Prallethrin and Cypermethrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. Allow surfaces to remain wet for 5 minutes. [Alternate: Spray surfaces until wet, but avoid excessive wetting and waste of product.]
- When treating for ants, spray around door and window frames. Also treat other entry points and trails. [Kills returning insects for up to 2 months\*\*.]
