USE RESTRICTIONS

THIS PRODUCT IS FOR OUTDOOR USE ONLY.

All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

- 1. Application to pervious surfaces such as soil, lawn, turf, and othervegetation;
- 2. Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch, or lawn);
- Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure;
- 4. Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
- 5. Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.), up to 2 feet above ground level;
- 6. Applications to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

Spot treatments must not exceed two square feet in size (for example, 2ft. by 1 ft or 4 ft. by 0.5 ft.).

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not spray the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

Do not allow the product to enter any drain during or after application.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

Do not apply or irrigate to the point of runoff.

Do not make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

Treat surfaces to ensure thorough coverage but avoid runoff

To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

Do not apply when the wind speed is greater than 15 mph.

Application Information

WASPS, HORNETS, MUD DAUBERS, AND YELLOW JACKETS:

- 1. Apply at sunset when insects are least active. To avoid contact with pesticide, apply with wind at your back.
- 2. Shake can well before each use.
- 3. Stand up to 20 feet [Alternates: 22, 25, 27, 29] away from nest. Aim at nest and push button to begin spraying. Slowly walk towards the nest while continuing to spray until nest is soaked. Do not stand directly underneath nest.

- 4. Focus spray on the nest. Do not target individual wasps, hornets, mud daubers or yellow jackets.
- 5. Wait at least 24 hours before removing the nest.

Do not use this product on evergreen and holly as damage may result.

*This product is non-staining to most home siding depending on age and cleanliness. Before using in areas where the spray may contact home siding, test in an inconspicuous area and recheck in a few hours.

OTHER PESTS

Tent Caterpillars: Apply in the late afternoon or evening when caterpillars have returned to their tents. Soak tents on all sides. **Spiders and Scorpions:** Stand at a safe distance and use the power of the jet spray to reach and cover the spider or scorpion.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store in a cool, dry (preferably locked) place that is away from heat or open flame, and in an area that is inaccessible to children and pets. Pesticide Disposal and Container Handling: Do not Puncture or Incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Do not pour or dispose down-the-drain or sewer. Call your local solid waste agency for disposal instructions.
