WASPS, HORNETS, MUD DAUBERS AND YELLOW JACKETS:

Application should be made in late evening when insects are least active. Spray liberally, soaking the nest. Wait at least 24 hours before removing the nest.

OPTION 2 – SIMPLIFIED DIRECTIONS

- 1. Apply at sunset when insects are least active (graphic-sunset)
- 2. Stand a safe distance from the nest. Don't stand directly underneath.
- 3. Shake can well before each use. Aim spray away from person. Push button to spray. (graphic-hand w/can)
- 4. Spray the nest until soaked. (graphic-nest).
- 5. Wait at least 24 hours before removing the nest.

USE TIPS

• If it's windy, stand with the wind at your back to avoid spray drift.

OTHER PESTS (For both formats)

Tent Caterpillars: Apply in the late afternoon or evening when caterpillars have returned to their tents. Soak tents on all sides. **Spiders and Scorpions:** Stand at a

safe distance and use the power of the jet spray to reach and cover the spider or scorpion. **Ants (excluding Fire Ants and Pharaoh Ants):** Spray trails, nest and point of entry. Spray on ants where possible.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
