The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cypermethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. - [1. For the initial use, remove the tie that is securing the handle to the base of the pump.
- 2. **REMOVE THE WAND** from the holster and **PULL THE HOSE** from the storage compartment.
- 3. Make sure the sprayer wand is securely tightened to the spray handle. (Graphical representation.)
- 4. **TURN THE PUMP HANDLE CLOCKWISE** to tightly seal the pump to the bottle and unlock the pump handle for pumping. (Graphical representation)

Where to use [Graphic showing Indoor treatment sites.]

For control of carpet beetles, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else insects are seen or suspected.

For control of fleas, thoroughly spray pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where fleas may be present. Pet bedding should be replaced with clean fresh bedding after treating the area. Do not treat pets with this product. To control the source of flea infestations, pets should be treated with a product registered for application to animals.

Note: Test inconspicuous sample of fabric or rug for staining before use. Check carpet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpeting.

For control of bed bugs and bed bug eggs: Apply as a spot treatment to cracks and crevices around baseboards, floorboards, bedboards and walls [night stand and dresser drawers][picture frames and wall hangings][crown molding][door and window casings]. Allow treated surfaces to dry thoroughly before use. Inspect area and repeat after 2 weeks [if necessary] while bed bugs are present. For persistent infestations consult a professional applicator.
