The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped “Notification” and will be placed in our records. The alternate brand name Black Flag® Flea & Tick Aerosol For Upholstery & Pet Bedding Plus Growth Regulator Home Treatment₂ has been added to the product record.

To kill fleas, thoroughly vacuum area to be treated. Treat carpeted areas and baseboards of hard surfaced floors. Evenly apply a fine mist or spray to carpets, rugs, drapes, and surfaces of upholstered furniture by using a wide sweeping motion. Also spray floors underneath furniture, sofas, chairs and beds. Do not saturate surfaces. Treat or thoroughly wash pet bedding, a primary hiding place for fleas. Repeat as necessary. **Do not spray humans or pets with this product.** For long-term flea emergence control (up to 7 months [210 days]), apply 16 oz per 300 square feet.

To kill insects, such as ants*, beetles, boxelder bugs, cockroaches, crickets, firebrats, grasshoppers, millipedes, moths, silverfish, spiders and stink bugs spray directly on pests.

* Except Fire, and Pharaoh Ants

To kill carpet beetles, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else insects are seen or suspected.

To kill dust mites, thoroughly vacuum entire room, concentrating on areas where dust mites congregate such as headboards, walls, floors, carpeting and baseboards. Apply directly to mites.

Note: Test inconspicuous sample of fabric, rug or other household surface for staining before use. Check carpet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpeting.
