The labeling referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended is acceptable with the following comments:

Under the Environmental Hazards section, delete the statement "Do not apply contaminate water with equipment wash waters" and replace it with the statement "Do not contaminate water when disposing of equipment washwaters".

Remove the Storage and Disposal block from underneath the Precautionary Statements section. The Storage and Disposal block must be placed in the Directions for Use section immediately before the specific directions for use or at the end of the directions for use. These statements must be set apart and clearly distinguishable from other directions for use.

Please submit five (5) copies of your final printed labeling incorporating the changes listed above before you release the product for shipment. A stamped copy is enclosed for your records.
