# DIRECTIONS FOR USE Ornamental Turf

LAWNS: For control of Imported Fire Ants, Chinch Bugs, Chingers, White Grubs, Wireworms, Culworms, Armyworms, Sod Webworms, June Beetle larvae, and Mole Crickets apply RIVERSIDE 10% HEPTACHLOR GRANULES at the rate of 1 pound per 2,000 square feet. Immediately after treatment drench lawn by sprinkling. This deposits granules under blades of grass onto the soil and out of contact of pets and children. Do not allow children or pets to use treated areas during treatment or sprinkling. Treated areas are safe to use after they are completely dry after sprinkling.

SOIL APPLICATION TO FIELD CROPS: Unless otherwise specified, make preplant soil applications just before or at planting time. Work into the top 3-6 inches of soil as scon as possible after application.
