#### GENERAL INFORMATION

RIVERSIDE NEMAGON 4.3 NEMATOCIDE is intended for application to mineral soil to control the plant parasitic nematodes awl, dagger, lance, lesion or meadow, pin ring, root-knot spiral, sting, stubby root, and stunt in land to be planted to crops listed in use directions.

#### DIRECTIONS FOR USE

Apply when soil temperatures are 40 to 80 F. at a depth of 6 to 8 inches. Soil should be in good tilth and contain adequate moisture for seed germination. Trash should be well decomposed. Do not treat extremely wet or dry soils nor heavy clay or muck soils.

Apply evenly at a depth of 6 to 8 inches below the normal soil surface. Seal the fumigant in by packing the soil surface with rollers or use light irrigation or some other means.

Use as a preplanting or at planting treatment of soil to be planted to snap beans, cabbage, carrots, cotton, cucumbers, lettuce, melons, peanuts, radishes, summer squash and tomatoes (direct seeded).

For broadcast treatment space injection chisels 12 inches apart and inject RIVERSIDE NEMAGON 4.3 NEMATOCIDE undiluted at 5 gallons per acre as a preplant treatment by soil injection.

For row treatment (40 inch spacing) inject RIVERSIDE NEMAGON 4.3 NEMATOCIDE undiluted at 1.75 gallons per acre. Plant directly in to treated strips following row application.

For other than 40 inch row spacings reduce the amount to apply per acre to be in proportion to the overall dosage and according to the actual fraction of the acre being treated. One chisel treats a 12 inch swath.

Wait 7 to 14 days before planting.

Do not feed plant parts to livestock. Forage crops grown on treated soil should not be used as feed for dairy animals or animals being finished for slaughter until two years after row treatment or three years after overall treatment. Do not feed, sell, or introduce into commerce hay or hulls grown on treated soil.

#### CONTAINER DISPOSAL

Destroy all containers when empty by punching holes in them and burying. Do not burn. Do not reuse containers for other purposes.
