APPLICATION THROUGH AN IRRIGATION SYSTEM (CHEMIGATION) - CRANBERRIES ONLY

DIAZINON 4AG may be applied along or in combination with other pesticides registered for application through sprinkler irrigation systems to cranberries. To insure compatibility, pour the products into a small container of water in the correct proportions. After thorough mixing, let stand for five minutes. If the combination lemains mixed, or can be remixed readily, the mixture is compatible.

Do not apply this product through any type of irrigation system to other crops. For chemigation, apply this product to cranberries only through sprinkler irrigation systems. Do not apply this product to cranberries through any other type of irrigation system.
