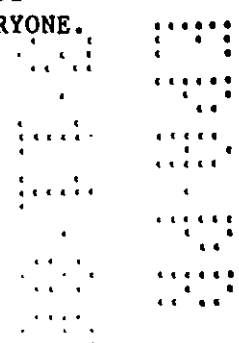

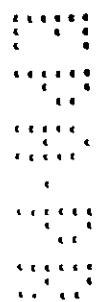

Maneb 8% is a special fungicide dust formulation for application on whole or cut potato tubers to protect them from seed-piece decay caused by *Fusarium bysambucinum*.

Use one (1) pound of Maneb 8% per 100 pounds of whole or cut seed potato pieces. Apply the dust in such a manner that the entire surface of each seed-piece becomes coated with the Maneb 8%.

Plant seed as soon after treatment as possible.

Under no circumstances use treated seed potatoes for food or feed purposes.
