GENERAL INFORMATION

CHLOROTHALONIL 90DF is an excellent fungicide when used according to label directions for control of a broad spectrum of plant diseases. CHLOROTHALONIL 90DF can be used effectively in dilute or concentrate sprays. Thorough, uniform coverage is essential for disease control. Do not combine CHLOROTHALONIL 90DF in the spray tank with pesticides, surfactants or fertilizers, unless prior use has shown the combination physically compatible, effective and noninjurious under conditions of use.

Dosage rates on this label indicate pounds of CHLOROTHALONIL 90DF per acre unless otherwise stated. Under conditions favoring disease development the high rate specified and shortest application interval should be used. Applications should be made in sufficient water to obtain adequate coverage of foliage. Gallonage to be used will vary with crop and amount of plant growth. Spray volume usually will range from 20 to 150 gallons (approximately 80 to 500 liters) per acre for dilute sprays and 5 to 10 gallons (approximately 20 to 40 liters) per acre for concentrate ground sprays and aircraft applications. Both ground and aircraft methods of application are recommended unless specific directions for ground application only are given for a crop. Application through sprinkler irrigation systems is recommended for some crops which are specified on the label below. Follow application and calibration instructions:

NOTE TO USER: Do not rotate to crops other than those listed on labels within 12 months of the last treatment. After 12 months from the last application, leafy vegetable (i.e. spinach lettuce, kale, etc.) may also be rotated.

mixinc PROCEDURES: Be sure sprayer is clean and not contaminated with any other materials, or crop if any or spraying clogging may refeat. Fill tank & full with clean water; start agitation. Be certain that the agitation system is working properly and creates a rippling or rolling action on the liquid surface. Pour product directly from container into tank. Let it wet and settle into water. Continue filling tank until 90% full. Increase agitation if necessary to maintain surface action. Finish filling tank. Maintain agitation during operation. Clean sprayer thoroughly immediately after use by flushing system with water containing a detergent. Do not use on greenhouse grown crops.

APPLICATION AND CALIBRATION TECHNIQUES FOR SPRINKLER IRRIGATION

Apply this product only through the following types of irrigation systems. Do not apply this product through any other type of irrigation system. Do not apply when wind speed favors drift beyond the area intended for treatment. Refer to GENERAL INFORMATION for agitation and mixing instructions.

A person knowledgable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

- A. Center Pivot, Traveler, Big Gun, Motorized Lateral Move, End Tow, and Side (Wheel) Roll Irrigation Equipment: Operate system and injection equipment at normal pressures recommended by the manufacturer of injection equipment used. Fill tank of injection equipment with water. Operate system for one complete circle for center pivot or one complete run for the other recommended equipment, measuring time required, amount of water injected, and acreage contained in circle or run. Mix recommended amount of CHLOROTHALONIL 90DF or acreage to be covered into same amount of water used during calibration and inject into system continuously for one revolution or run. Shut off injection equipment after one revolution or run, but continue to operate irrigation system until CHLOROTHALONIL 90DF has been cleared from last sprinkler head.
- B. Solid Set and Hand Move Irrigation Equipment: Determine acreage covered by sprinkler. Fill tank of injection equipment with water and adjust flow to use contents over a thirty to forty-five minute period. Mix desired amount of CHLOROTHALONIL 90DF for acreage to be covered into quantity of water used during calibration and operate entire system at normal pressures recommended by the manufacturer of injection equipment used for amount of time established during calibration. Provide constant mechanical agitation in the mix tank to insure that CHLOROTHALONIL 90DF will remain in suspension during the injection cycle. CHLOROTHALONIL 90DF can be injected at the beginning or end of the irrigation cycle or as a separate application. Stop injection equipment after treatment is completed and continue to operate irrigation system until CHLOROTHALONIL 30DF has been cleared from last sprinkler head.

SAFETY DEVICES

BEST AVAILABLE COPT.

A. The systems designated above must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow. All pesticide injection pipelines must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to he system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

B. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

SYSTEMS CONNECTED TO PUBLIC WATER SOURCES

Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide latel-prescribed safety devices for public water systems are in place.

Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pestic. 'e introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.



POSTING INSTRUCTIONS FOR PRODUCTS LABELLED DANGER

Posting Instructions: Posting of areas to be chemigated is required when any part of a treated area is within 300 feet of sensitive areas such as residential areas, labor camps, businesses, day care centers, hospitals, in-patient clinics, nursing homes, or any public areas such as schools, parks, playgrounds, or other public facilities not including public roads.

Posting must conform to the following requirements. Treated areas shall be posted with signs at all usual points of entry and along likely routes of approach from the listed sensitive areas. When there are no usual points of entry, signs must be posted in the corners of the treated areas and in any other location affording maximum visibility to sensitive areas. The printed side of the sign should face away from the treated area towards the sensitive area. The signs shall be printed in English. Signs must be posted prior to application and must remain posted until foliage has dried and soil surface water has disappeared. Signs may remain in place indefinitely as long as they are composed of material to prevent deterioration and maintain legibility for the duration of the posting period.

All words shall consist of letters at least 2½ inches tall, and all letters and ... the symbol shall be a color which sharply contrasts with their immediate background. At the top of the sign shall be the words KEEP OUT, followed by an octagonal stop sign symbol at least 8 inches in diameter containing the word STOP. Below the symbol shall be the words PESTICIDES IN WATER.


