

### DIRECTIONS FOR USE

Pour recommended amount of this material on surface of water in nearly filled spray tank. Add balance of water to fill tank. Keep agitator running during filling, mixing, and spraying operations. Do not allow mixture to stand. Do not combine wettable powders with emulsifiable liquids in the same spray tank unless previous use of the materials being combined has proved them to be physically compatible.

Dosages are given in terms of pints per acre. Use sufficient water for thorough coverage.

**BEANS:** Bean Leafroller, Serpentine Leafminer. Apply at the rate of 2 pints per acre. Make 2 applications at 15 day intervals. Make no application to green or snap beans after pods start to form. **DO NOT FEED TREATED FORAGE TO DAIRY ANIMALS OR TO ANIMALS BEING FINISHED FOR SLAUGHTER.**

**COLE CROPS:** (Broccoli, Brussels Sprouts, Cabbage, Cauliflower): Armyworms, Imported Cabbage Worm use 2 pints per acre. Cabbage Looper, Climbing Cutworms, apply 1 - 1/2 pints per acre at 7-10 day intervals. **DO NOT APPLY AFTER EDIBLE PARTS BEGIN TO FORM.**

**TOMATOES:** Cabbage Looper, Climbing Cutworms, Flea Beetle, Hornworm, Tomatoe Fruitworm. Apply at the rate of 1 1/2 - 4 pints per acre. **DO NOT APPLY WITHIN 3 DAYS OF HARVEST.**

**COWPEAS:** Cowpea Curculio — Use 1 1/2 - 2 pints per acre. Do not apply to cowpeas to be used as green snaps after pods begin to form. **DO NOT FEED TREATED FORAGE TO DAIRY ANIMALS OR TO ANIMALS BEING FINISHED FOR SLAUGHTER.**

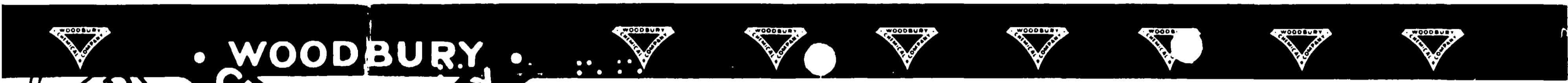

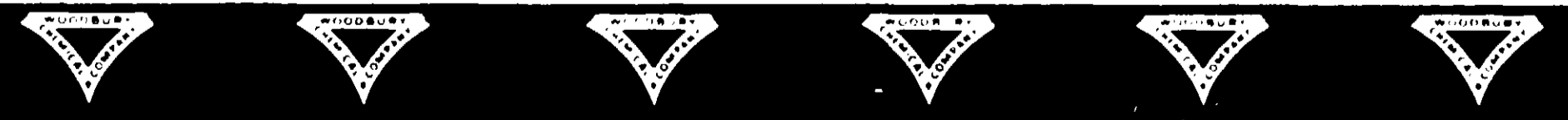
