TURF: Chiggers, Ticks: Use at the rate of 1/3 oz. in 1 gallon of water applied to 100 sq. feet of turf. Do not treat on area larger than 100 sq. feet.

PINE TREES: Ips Pine Bark Beetles: Use at the rate of 2 to 4 gallons per 100 gallons of spray. Spray infested trees and nearby trees that are in a weakened condition to the point of run-off. Spot treatment in ornamental plantings only.
