Fiebing's Flyspray 44 has been especially formulated for use on horses. It provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1-2 ounces per head per day gives adequate protection. Apply with either soft cloth or fine mist spray.

Remove or cover exposed foods before spraying. Do not apply to dairy animals.

USE TO WIPE ON:

First, brush animal to remove excess dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against the hair growth. Only a light application is required. Avoid using an excessive amount on your horses. Do not wet skin.
