 - c) Under Environmental Hazards revise the first sentence to read "This product is extremely toxic to fish and other aquatic organisms."

- d) Delete the paragraph beginning "Do not use in commercial food/feed handling establishments etc." and ending "Remove or cover exposed food prior to treatment." Since this product is for use on horses and animal quarters only the above paragraph is not required.

Note: You are not required to have an *If inhaled*, first aid statement nor do you need "*Harmful if inhaled*" & "*Avoid breathing spray mist.*" precautions in the Precautionary Statements. The acute inhalation toxicity was formerly Category III but now by current standards is classified as a Category IV. You may delete these statements if you wish.

3. Please submit two (2) copies of your final printed label for before your release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

Kills and repels *Horse Flies*, *Stable Flies*, *Horn Flies*, *House Flies*, *Face Flies*, *Deer Flies*, *Mosquitoes*, *Fleas*, *Gnats*, *Lice* and *Ticks*. Not for application if horses will be used for food.

Directions for Wipe-on Use: Thoroughly brush horse to remove excess dirt and dust. Extremely dirty horses should be washed, and allowed to dry before applying product. Use a sponge or clean soft cloth or mitt. Apply Fiebing's EquiPend liberally over areas to be protected. Pay special attention to legs, belly, shoulders, neck and facial areas. Avoid eyes and mucous membrane.

Directions for Trigger Spray Use: Remove excess dirt and dust. Apply light mist to coat while brushing lightly against lay of hair. Avoid spraying in eyes, nose or mouth.

TO KILL AND REPEL FLYING INSECTS IN ANIMAL QUARTERS: Spray in areas where insects congregate. Direct spray to contact insects for rapid knockdown and kill. Spray around outside of door facings, around windows, and on screens to render areas unattractive to insects. This helps to repel insects and prevent entrance into buildings.

Storage: Store in original container in a cool, dry place inaccessible to children and pets.
