DIRECTIONS FOR USE

TO OPERATE: Hold can upright and spray infested surfaces only until wet.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily into all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelvings. Repeat as necessary.

BROWN DOG TICKS: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Applications should be repeated as infestations warrant and as re-infestations occur. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

FLIES, MOSQUITOES, WASPS AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

FLEAS, CHIGGERS, ANTS AND BROWN DOG TICKS OUTDOORS: For treatment of localized outdoor infestations, spray weeds and non-crop vegetation in areas around the home. For ants, thoroughly wet hills and mounds. Repeat applications as infestations warrant and as re-infestations occur.

Places other than private residences in which exposed food is held, processed, prepared, or served.

FOOD AREAS-APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY- Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing) preparing, edible waste storage and enclosed processing systems (mills dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation also would be considered a food area).

Apply in small amounts directly into cracks and crevices using injection tube in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where roaches, ants, waterbugs, silverfish, spiders and crickets hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS, OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.

SERVING AREAS-Facilities where prepared foods are served, such as dining rooms, but excluding areas where foods may be prepared or held.

Apply as a spot treatment to selective surfaces such as baseboards, under elements of construction into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)
