**DIRECTIONS**

To control **Flies, Mosquitoes, Gnats** and **Flying Moths (Millers)**: Apply using a good space sprayer adjusted to deliver a fine mist. Close windows and doors and shut off ventilating systems. Direct spray toward upper portions of the enclosure, filling the atmosphere with mist. Use 2 to 3 ounces per 1000 cubic feet of space. For best results, keep area closed for at least 10 minutes. Vacate treated area and ventilate before reoccupying. Repeat treatment as necessary.

To control **Silverfish, Crickets,** and **House Spiders**, spray thoroughly into hiding places particularly in cracks, crevices, moist areas, around openings for plumbing or wiring, under sinks, cabinets, stoves, refrigerators, pallets. Spray insects directly whenever possible. Repeat treatment as necessary.

To control **Ants**, spray trails, nests, and points of entry. Spray directly on ants whenever possible. Repeat treatment as necessary.
