RITE OFF Roach & Ant Killer One with BAYGON.

Note to Physician. Contains petroleum distillate. If gastric lavage is deemed necessary undertake after proper placement of cuffed endotracheal tube. Active ingredients contain a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife. Do not apply directly to lakes, streams and ponds. Do not contaminate water by cleaning of equipment or disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS: Extremely Flammable. Contents under pressure. Keep away from fire sparks and heated surfaces. Do not puncture or incinerate container. Exposure to temperatures above 130° F may cause bursting. **Directions:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. **To Operate:** Hold can upright and spray infested surface only until wet.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily into all cracks around baseboards and other places where these insects hide. Also spray until wet surfaces behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat as necessary.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelving. Repeat as necessary.

BROWN DOG TICKS: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Applications should be repeated as infestations warrant and as re-infestations occur. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

FLIES, MOSQUITOES, WASPS AND FLYING MOTH: OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

FLEAS, CHIGGERS, ANTS AND BROWN DOG TICKS OUTDOORS: For treatment of localized outdoor infestation. Spray weeds and non-crop vegetation in areas around the home. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as re-infestations occur.

Keep away from food, feedstuffs and domestic water supplies. Do not smoke while using. Wash thoroughly after handling. Wash contaminated clothing before reuse.
