Storage: Store in a cool, dry area away from heat or open flame.

Disposal: Do not re-use empty container. Wrap container and put in trash collection.

This product will kill Cockroaches, Houseflies, Confused Flour Beetles, Saw-toothed Grain Beetles, Rice Weevils, Small Flying Moths, Fleas, Ticks, Pill Bugs, Crickets.

Cover exposed food, dishes and foodhandling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where flow of fresh air is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for four hours before going out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary. To Kill Ticks and Fleas: Destroy old pet bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to re-entry.
