### PRECAUTIONARY STATEMENTS

# Hazards to Humans & Domestic Animals CAUTION

Avoid inhalation or ingestion of spray. Wash hands thoroughly after use. Avoid contamination of feed and foodstuffs.

Do not spray directly in/on eyes, mouth or genitalia of pets. Do not treat or cause exposure to kittens or puppies less than four weeks old.

#### Environmental Hazards

This product is toxic to fish. Do not apply directly to lakes, streams, ponds, tidal marshes and estuaries. Do not contaminate water by cleaning of equipment of disposal of wastes.

#### Physical and Chemical Hazards

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container, Exposure to temperatures above 130°F may cause bursting.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### SHAKE WELL BEFORE USING.

Remove protective cap, hold container upright and spray from a distance of 12 to 15 inches.

INDOOR APPLICATION: The use of this product in food processing establishments should be confined to time period when the plant is not in operation. Food should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned with potable water before using. Vacate treated areas and ventilate before reoccupying.

FLEAS (ADULTS AND LARVAE) AND TICKS: Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices, around baseboards, and window and door frames. Infested upholstered furniture may also be treated with this product. A test application should be made to upholstery or drapery fabrics in an inconspicuous place before use.

COCKROACHES, WATERBUGS, SILVERFISH, CRICKETS, SPIDERS: Spray directly on beetles, baseboards, floors, shelves and carpets. Repeat treatment if necessary.

ANTS: Spray trails, nest and points of entry. Spray on ants where possible. Repeat if necessary.

CARPET BEETLES: Spray directly on beetles, baseboards, floors, shelves and carpets. Repeat treatment if necessary.

SPACE SPRAYING: Close doors, windows and transoms and shut off ventilating systems. For rapid control of House Flies, Fruit flies, Gnats, Mosquitoes, Skipper Flies, Wasps, Hornets, Angoumois Grain Moths, Mediterranean Flour Moths, Indianmeal Moths and Tobacco Moths, direct spray at an upward angle distributing it unformly throughout the entire area at a rate of 3-6 ounces per 1000 cubic feet of space. Do not remain in treated areas. If insects have not dropped to floor in 3 minutes, repeat spraying as quantity sprayed was insufficient. Ventilate the area after treatment is completed. To aid in the prevention of breeding, spray on standing water and in garbage pails.

WASPS & HORNETS: Spray directly on insects whenever possible. Apply a wet spray after dark when all insects have returned to their nests.

OUTDOORS (camping, fishing, hunting): spray outer clothing and surroundings. Repels Biting Flies, Mosquitoes, Midges and Gnats. If sparayed every hour or so, will aid in keeping surroundings free from Mosquitoes, If in rare cases skin irritation results, avoid continued contact.

**Storage:** Store in original container in a cool, dry place inaccessible to children and pets.

**DISPOSAL:** Replace cap and discard container in trash. Do not puncture or inclinerate.
