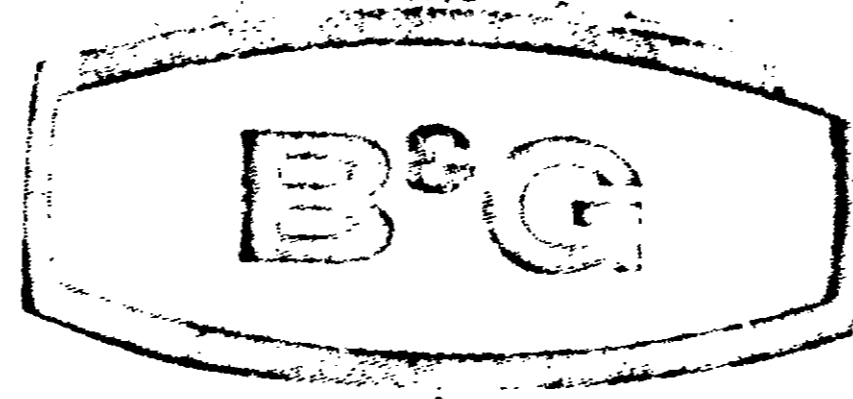

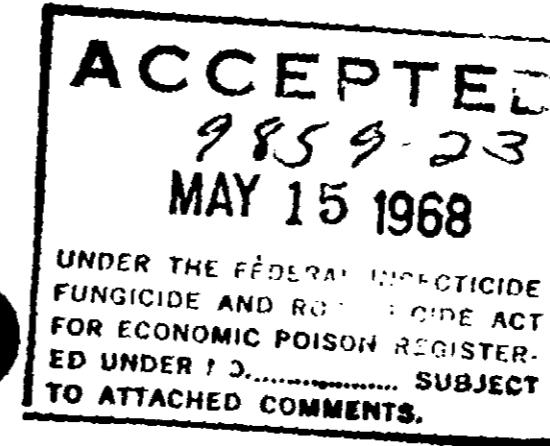

DIRECTIONS

DMA-100 (100% DSMA Hexahydrate) is a selective water soluble herbicide used Post-Emergence for DALLISGRASS control in Bermuda Turf.

For best results soil should be moist at time of application.

Dry soil may not allow desirable turf to resist the action of chemicals. Water thoroughly before treatment, especially during drouth, extreme heat and low soil moisture.

RECOMMENDED RATES TO TREAT ONE (1) ACRE

Mix **3 to 4 lbs.** of DMA-100 in **50 to 75 gallons** of water. Add **1 quart** of Wetting Agent. **NOTE:** Wetting Agents are used to decrease run-off and increase effectiveness of chemical through leaf absorption.

For complete control of broadleaf as well as grassy weeds, add **1 pint** of 2, 4-D (40% Amine) to solution.

DMA-100, is effective at the above rates when air temperature is 80°F. or higher. For temperatures below 80°F use twice the amount of DMA-100 to treat the same area.
