(UNICLEAN 80/85) is an effective multi-purpose cleaner, disinfectant and deodorizer against gram-negative bacteria for household and industrial use. (UNICLEAN 80/85) should be used at regular intervals as indicated below.

FOR CLEANING BEFORE DISINFECTION:  
Heavily soiled areas should be mopped or brushed with a solution containing two ounces of (UNICLEAN 80/85) per gallon of water. Rinse cleaned surfaces with fresh water.
