WS-50 WEED SPRAY

WS-50 WEED SPRAY is recommended for killing and controlling unwanted growth along fence rows, around lumber yards, along railroad right-of-ways, pipe lines, around houses and truck stops, and similar places.

Mix 10 to 20 gallons **WS-50 WEED SPRAY** with 100 gallons of diesel fuel, kerosene, crankcase drainings or other oil for each acre to be sprayed (this gives 17-24" spray). Apply thoroughly, wet weeds. Spray on foliage and stems to ground line when plants are in full leaf and up to 2 to 3 weeks before first expected frost in the area. For hard to kill growth a stronger mixture should be used.

Where minimum fire hazards are desired **WS-50 WEED SPRAY** may be diluted with water to obtain an emulsifiable spray mix. Mix 25 gallons **WS-50 WEED SPRAY** with 25 gallons of water for each acre. Apply this spray to thoroughly cover all weeds.

Spot treatment of any retreats of undesirable vegetation is recommended.
