

GENERAL INFORMATION

This is a specially formulated non-soluctive chemical for controlling a wide range of annual and perennial weeds and grasses. It is recommended for use only on non-cropland areas such as railtied rights-of-way and industrial sites. The degree of control and duration of results depends on the amount of product applied, soil type, rainfall and other conditions. Highly recommended for numerical weed control and as a semi-soil step-

DIRECTIONS

To control most weeds and grasses on non-cropland areas for an extended time, apply 43.5 gallons per acre(1 gal, <1000 sq. ft.) of undiluted weed killer after the most predominant weeds have emerged. No agitation is required. Weed Killer should be applied with radicad on-track, truck mounted, or other standard spraying equipment. For treating small areas, a tank-type hand sprayer or sprinkling can may be used.
