DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its label.

TO KILL CARPET BEETLES: Dilute 1 part insecticide with 9 parts water. Spray liberally all infested areas, paying particular attention to cracks, crevices, and other hiding places. Spray liberally the underside of infested carpets. Repeat as needed.

TO KILL FLIES, MOSQUITOES AND GNATS: Dilute one part insecticide with 19 parts water and spray vigorously in all parts of room, using about 1 ounce for each 1000 cubic feet of space. Leave room closed for 15 minutes. Sweep up and destroy fallen insects. Repeat as needed.

TO KILL FLEAS (Intesting Premises): Dilute 1 part insecticide with 15 parts of water. Remove and destroy animals' bedding and spray sleeping quarters liberally, forcing the spray into all cracks in floor and about room. Repeat when necessary.

TO KILL ROACHES & WATERBUGS: Dilute 1 part insecticide with 9 parts of water and spray to point of run-off all cracks, crevices, underneath sinks, behind pipes, around base of all machines, pay particular attention to dark areas in which roaches might hide or nest. Contact as many insects as possible while spraying. Repeat as necessary.

TO KILL THE ACCESSIBLE STAGES OF GRANARY INSECTS SUCH AS: WEEVILS, FLOUR BEETLES, MEAL MOTH LARVAE & ADULTS, CADELLES & SAW-TOOTHED GRAIN BEETLES: Dilute 1 part insecticide with 9 parts of water. To control the crawling or immature forms, apply to point of run-off to all areas infested by these insects. Pay particular attention to cracks and crevices in floors, walls and ceilings. Spray thoroughly around and into floors drains, conveyors and other areas where granary insects may be found. (For flying moths, treat as for flies, mosquitoes and gnats. See directions above.)
