DIRECTIONS

ANTS, ROACHES, CRICKETS, CLOVER MITES, EAR-WIGS, SCORPIONS, SILVERFISH, SPIDERS.

Water solution - dilute 3 tablesponfuls of insecticide concentrate in 1 quart of water, or 6½ ounces per gallon.

Oil solution - dilute 1 part of insecticide concentrate in 19 parts of a mixture containing 4 parts kerosene and 1 part toluene.


Apply by means of a coarse spray, paint brush, or low pressure spray bomb to window sills, baseboards, drainboards, under sinks, stoves, cracks crevices and to other, areas frequented by insects. Avoid contamination of of food utensils, milk, milk equipment, and water.

CARPET BEETLES, CLOTHES MOTHS -- Dilute Insecticide concentrate as indicated above (ANTS . . . etc.) Apply to baseboards, (floors including areas under carpets, a long margins of carpets and in closets), behind radiators and other lint accumulation areas, closet shelves and walls, and infested surface areas of carpeting.

If clothing or woolen goods are to be protected from clothes moth attack they should receive regular treatments with a suitable moth proofing material.

ANT MOUNDS - ADD 1½ pints of Insecticide Concentrate to 100 gallons of water spray ant hills thoroughly and mix moist earth in the top of the hill. For other small ants in flower beds, lawns, around trees, spray lightly in the infested areas. Repeat in 10-15 days if ants return.

LAWNS - For the control of ground pearls in lawns, apply Insecticide Concentrate at the rate of 3 to 4 quarts per acre in 100 gations of water. Make full coverage application to soil surface when ground pearl nymphs are in the pink, "crawler", or active stage and immediately wash into soil with additional water.
