

Precautionary Statements

Hazards to Human and Domestic Animals

CAUTION

Harmful if swallowed or absorbed through skin. Avoid contact with skin, eyes, or clothing. Remove fish, birds, and other pets from area to be treated. Avoid breathing mist.

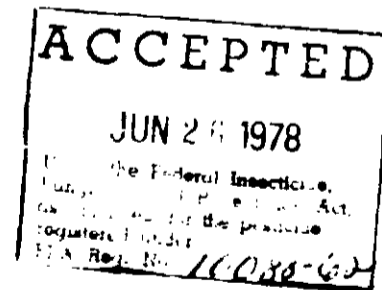
Use in hotels, motels, homes, institutions, packaging and non-food areas of packing and processing plants, seed homes, and horse stalls.

NOTE - Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

SPACE SPRAY - To kill flies, mosquitoes and gnats. Close room or area to be treated. Shut off air-conditioner and ventilator system. Seal all open vents. Remove fish and pets. Apply undiluted as a very fine mist space spray through manually operated equipment or with electrical and other powered applicators. Avoid staining by holding the spray nozzle at least five feet from objects. Direct the fine spray mist toward the upper corners of the room. Fill the room with a fine mist space spray, at the rate of 5 fluid ounces per 5,000 cubic feet. Leave room closed for one half hour. Ventilate thoroughly before re-entry.

CONTACT SPRAYS - For control of roaches, ants, earwigs, grain mites, sowbugs, spiders and centipedes - Adjust spray to product large wetting type spray particles. Direct spray to contact these insects in cracks and crevices in floors, baseboards, around pipes, behind cabinets, and other harbourages. Spray these infested areas until thoroughly wet. Repeat as necessary.
