PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS & DOMESTIC ANIMALS

WARNING: KEEP OUT OF REACH OF CHILDREN

Causes substantial but temporary eye injury. Do not get in eyes or on ciothing. Wear protective evewear (popples, face shield, or safety plasses). Wash thoroughly with soap and water after handling. The maximum number of broadcast applications to turf per treatment site is 2 per year. Do not allow people (other than applicator) or pets on treatment areas during application. Do not enter treatment areas until spray has dried.

If this container is over one gallon and less than five gallons, the person engaged in open pouring of this product must also wear coveralis or a chemical-resistant agron. If this container is five gallons or more in capacity, then a mechanical system (probe and pump) must be used for transferring the container of this container. STATEMENT OF PRACTICAL TREATMENT:

IF \$WALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by fouching back of threat with finger. Do not induce vomiting or give anything by mouth to an unconscious person, Get medical attention immediately.

IF ON SKIN: Wash skin with soap and water. Get medical attention if Irritation persists.

ENVIRONMENTAL HAZARDS:

This product is toxic to aquatic invertebrates. Drift or runoff may adversely affect aquatic invertebrates and non-target plants. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water supply when disposing of equipment wash water. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with

IMPORTANT: Do not use this product for controlling weeds in flower or vegetable beds, or around strube or ornamental plantings. Do not reseed for 3 to 4 weeks after use. If lawn needs watering, water thoroughly before application. Do not water for 48 hours after application. Spray entire lawn, wetting weeds and lawn grasses, do not overspray. Spray when air is calm to avoid spray drift that might injure desivable ornamental plants. Do not apply when temperatures are expected to exceed 85°F, within 24 hours of application. Make a new distribution for each use. Do not apply through any type of irrigation system. Avoid spray drift to vegetables, flowers, ornamental strube, trees and other destrable plants. Coarse aprays are less likely to drift.

NEWLY SEEDED LAWNS may be treated after they have been mowed at least 3 times. BENT, RED FESCUE, CENTIFEDE AND CARPET GRASSES: Use one-half the recommended rate (2 teaspoons of product per gallon of water covers 200 eq. (t.). Make 2 applications 10 days apart. Do not apply to Dichondra, Lippia, St. Augustine and Clover lawns.

EFFECTIVE FOR THE CONTROL OF: BURDOCK, CANADA THISTLE, CHICORY, CHICKWEED (MOUSE-EAR, COMMON & STITCHWORT), CLOVER, DANDELION, DOCK, DOG FENNEL, ENGLISH DAISY; FRENCHWEED, GROUND 1VY. HAWKWEED, HEALALL, HENBIT, JIMSON WEED, KNOTWEED ERECT AND KNOTWEED PROSTRATE, LAMBSQUARTER, MALLOW, MORNING GLORY, MUSTARD, OXALIS, PENNYWORT, PEPPERGRASS, PIGWEED, PLANTAIN, POISON IVY, POISON OAK, PURSLANE, RAGWEED, SMARTWEED, SMEEP SORRELL, SPOTTED SPURGE, WILD ASTER, WILD CARROT, WILD GARLIC, WILD GONG, WOOD SORRELL AND MANY OTHER BROADLEAF WEEDS.

LAWN WEEDS: To kill dandskion, wild onion, pennywort, healall, plantain and similar weeds: Use 8 conces in 6 gallons of water and apply with pump or hose-end sprayer or sprinkling can to 2,500 square feet of lawn. For smaller areas, use 2 teaspoons in 2 quarts of water applied to 100 square feet. For larger areas, use 1 gallon in 50 gailons of water applied to 1 acre.

To kill weeds such as thistes, bindweed, dock and ragweed, use 8 ounces in 6 gallons of water (or 2 teaspoonful in 2 quarts of water), and apply directly to plants, wetting them thoroughly. Repeat as necessary. For larger areas, use 1 gallon in 50 gallons of water.

To kill undestrable plants such as poison by or poison oak, use 8 teaspoonfuls in 2 quarts of water or 1 gallon in 12-1/2 gallons of water and drench plants when they are in full leaf. Repeat in 4 weeks if necessary. Certain hard-to-kill weeks such as poison by, polson bak and English dalay may require a fall application.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. Do not store near heat or open flame. Store above 32°F. If product freezes, mix thoroughly before using. This does not after the product. Keep container fightly closed when not in use. If container is damaged or leading, contain spill. Soak up spilled material with absorbert and place in closed, labeled container for proper disposal. PESTICIDE DISPOSAL: Pesticide wastes are toxic, Improper disposal of excess pesticide, spray moture or virsate is a violation of Federal law and may contaminate groundwater.
