The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

1. Change the heading of the precautionary statement to read "Hazards to Human and Domestic Animals". This product has a residential use pattern and it is likely that domestic animals could come into contact with this product.
2. Remove claim #16 - "Towels do not produce "fall-out" making them safe around plants."
3. Remove claim #15 - "Environmentally safe - contains no CFCs or HCFCs."

Submit two copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records. If you have any questions, please contact Kevin Sweeney at (703) 305-5063.

Use just enough repellent to cover exposed skin and/or clothing. After returning indoors, wash treated skin with soap and water. Wash treated clothing. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local poison control center. If you go to the doctor, take this repellent with you.

Avoid contact with plastic, such as eyeglass frames, and such fabrics as acetate rayon.

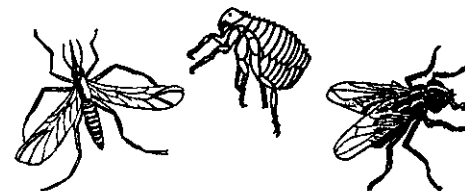
