NX-135 Microbiocide is used in cooling water systems and industrial air-washing systems to control microbiological slime. In cooling systems, add 1.6 to 4.9 fl. oz. of NX-135 Microbiocide per 1000 gal. of water to the cooling tower sump. In air-washing systems, add 5.7 to 9.8 fl. oz. of NX-135 Microbiocide per 1000 gal. of water to watercollection trays. Repeat treatments every 1-5 days, or as needed. The required frequency depends on relative amount of bleed and severity of slime problem.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.
