## FEEDING DIRECTIONS

Self-feed King-K BAR-FLY Blocks. Place blocks in bunks, mangers, sheds or on pasture near watering and/or loafing areas. Place fresh blocks before animals once or twice weekly - at least one block for every 10 head.

KING-K BAR-FLY Blocks contain all of the salt and minerals required by cattle and should be self-fed as the sole source of salt.

A 750 lb. animal will consume approximately one-third pound of block per head daily. The salt is a built-in aid to control consumption.

It is desirable when starting the BAR-FLY program to spray the cattle to kill existing adult flies. King-K Bar-Fly Block is designed to prevent the breeding of new flies, but will not affect the existing fly population.

**CAUTION:** Keep out of the reach of children.  
Do not feed to lactating dairy cows.  
Occasional sensitivity to phenothiazine has been reported in cattle.
