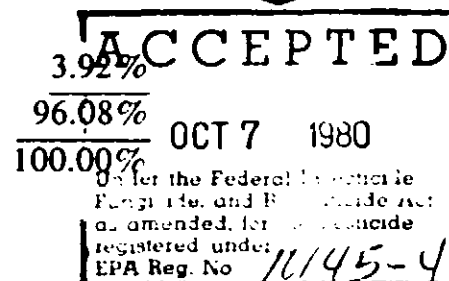

A SOLVENT TYPE FUNGISTATIC AGENT THAT INHIBITS MOLD AND MILDEW ON FINISHED LEATHER.

PHYSICAL HAZARD — DO NOT POUR, SPILL OR STORE NEAR OPEN FLAME OR HEAT.

DIRECTIONS: THIS MATERIAL COMES READY FOR USE AND SHOULD BE APPLIED IN A WELL-VENTILATED SPRAY BOOTH WITH AN AIR PRESSURE OF 30-40 POUNDS.

APPLY SO AS TO OBTAIN 1.5% ORTHO-PHENYL PHENOL BASED ON WEIGHT OF THE LEATHER. 1 GALLON WEIGHS 6.8 POUNDS.

DANGER - KEEP OUT OF REACH OF CHILDREN

DANGER: Corrosive. Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

FIRST AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.
