Sodium 2,4,5-trichlorophenate 17.00% 4-chloro-2-cyclopentylphenol 5.76% 22.76%

Inert ingredients: 77.24%

A bacteriostat used to control the growth of bacteria on brine cured cattle hides and leather.

DIRECTIONS: For each batch of hides add 50 pounds VITA-SAN X100 slowly to raceway which contains about 28,000 gallons saturated brine. About 1000 hides averaging 45 to 50 pounds each is considered a full load. Processing time is about 18 to 24 hours.
