

Precautionary Statement
Hazards to Humans and Domestic Animals

DANGER

CORROSIVE: Causes irreversible eye damage or skin burns. Due to irritancy nature, may be harmful or fatal if swallowed or absorbed through the skin. Do not get in eyes, on skin or on clothing. Wear a face shield or goggles. Wear protective clothing and rubber gloves. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

FIRST AID STATEMENT

IF SWALLOWED: Call a physician or poison control center. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF IN EYES: Hold eyelids open and flush with steady, gentle stream of water for 15 minutes. Get medical attention.

NOTE TO PHYSICIAN

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be necessary. Supportive care treatment based on judgement of the physician. If lavage is performed and burn is present, treat as any thermal burn, after decontamination. No specific antidote. ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high watermark.
